

# Rules of the Magdalene College Amalgamation Club.

## I.—THE FINANCE COMMITTEE.

1. The Finances of the College Boat, Cricket, Athletics, Rugby Union and Association Football, Hockey, Lawn Tennis Clubs, the Reading Room, and the College Magazine, shall be made under the management of a Committee, consisting of a Permanent Treasurer (to be appointed by the Committee), an Honorary Secretary, with Assistant Secretary, if necessary (to be elected at a General College Meeting), the Captains and Secretaries of the various Clubs, and the Editor of the Magazine.
2. Of this Committee the Treasurer shall act as Chairman, having both vote and casting vote, six Members forming a quorum.
3. No Member of the Committee shall serve in more than two capacities.
4. The Committee shall meet to consider matters of Finance when they arise, and shall be called by the Hon. Secretary.
5. A General Meeting of the College may at any time be called by an application to the Hon. Secretary of Committee, signed by any ten Members of the Amalgamation Club. Notice of such Meeting, together with the object of the Meeting, to be posted by the Hon. Secretary 48 hours before date of Meeting.
6. An ordinary Meeting of the whole College shall be held each Term, and a special Meeting for the Election of Officers at the end of the Easter Term. At this Meeting all Captains and Secretaries of the various Clubs, with the Hon. Secretary of Committee, shall resign their offices. At these Meetings the President shall only have a casting vote.
7. Before any Election the names of proposed Officers of any Club shall be sent in, together with the names of the proposer and seconder, to the Honorary Secretary, in time to be posted on the Notice Board by Hall time on the night before the Meeting for Election. Officers of a Club may only be nominated by Members who have represented that Club on three or more occasions; and the Editor and Committee of the Magazine must be nominated by Members of the retiring Committee.
8. In all matters not affected by the Rules of the Amalgamation Club the Rules of the Old Clubs shall hold good.

## II.—SUBSCRIPTIONS.

1. The Finance Committee shall levy an Entrance Fee of Thirty Shillings, and a Terminal Subscription of Two Guineas a head on behalf of the Amalgamated Clubs, which shall admit the Subscriber to all advantages of the several Clubs. Any Freshman may compound all Subscriptions by payment of £15 6s.
2. After a Member has paid nine Terminal Subscriptions, he shall be considered a Life Member, and shall be exempt from all further payments.
3. No Member, whose Subscription for the previous Term is still due, shall on any account act as official of, play for, or represent any of the Amalgamated Clubs, and any Captain or other Official who permits such a Member to play shall be liable to be dismissed from his office.
4. It shall be the duty of the Hon. Secretary to present a Copy of these Rules to every new Member of the College, and to ascertain whether he will become a Member of the Club; and if so to receive his entrance fee.\*

\* Terminal Subscriptions are payable either to one of the Secretaries, or, by the Tutor's permission, through the College Account.

## III.—CLUB ACCOUNTS.

1. The income arising from Entrance Fees, Terminal Subscriptions, and Compounding Fees, shall be apportioned to the various Clubs to meet their expenses, but no extraordinary expenditure shall be allowed without the sanction of the Finance Committee.
2. All payments above £3 shall be made by cheque signed by the Treasurer of the Amalgamation Club. Smaller payments may be made by the Secretary of each Club, who shall keep a petty cash account of all moneys received by him from the Treasurer, and receipts shall be demanded by the several Secretaries on payment of all sums.
3. The accounts of each of the Amalgamated Clubs shall be audited at the end of each year by the Tutor, and presented and passed at a General Meeting held early in the ensuing Term.

## IV.—"COLOURS."

The "Colours" of the various Clubs are as follows:—

*Second Lent Boat*: Plain zephyr with trimming on arms, socks, blazer with silk trimming.

*First Lent Boat*: Fully trimmed zephyr, socks, blazer with additional trimming on pockets.

*Second May Boat*: Fully trimmed zephyr, socks, Second Lent blazer with "cannibal" badge on pocket.

*First May Boat*: Fully trimmed zephyr, socks, fully trimmed blazer with wyvern on pocket, cap, hatband, scarf, trimmed sweater, and tie.

*Cricket*: Blazer with badge on pocket, cap with badge, tie and scarf.

*Rugby Football*: Wyvern on jersey, cap, M.C.R.F.C. on pocket of Amalgamation blazer, or striped blazer.

*Association Football*: Badge on shirt, cap, M.C.A.F.C. on pocket of Amalgamation blazer, or striped blazer.

*Tennis*: Blazer with cross rackets on pocket, scarf.

*Hockey*: Badge on shirt, cap, shorts and zephyr trimmed.

*Athletic Club*: Blazer with wyvern and M.C.A.C. on pocket, scarf, shorts and zephyr trimmed (Half Colour, shorts and zephyr only).

*Any proposed alteration in the above Rules must be submitted to a General Meeting of the College.*
